Designation: Emergency ventilator Oxylator FR-300 with connection hose, mini nozzle and test lung

Description: The FR-300 can also be used in toxic atmospheres thanks to its independence from recirculated air, making it an ideal ventilator for fire departments in the event of fire or hazardous goods incidents.

The device automatically recognizes the optimum ventilation volume for each patient thanks to its automatic pressure/flow system. The Oxylator FR-300 can be connected directly to the patient's mask or by means of a goose gurgler.
